

## CONDITIONS OF PARTICIPATION - Raffle B2B (Film Stretching Industry)

These conditions of participation govern the participation in and implementation of the 1,000 upgrade raffle both via <https://www.brueckner-servtec.com/en> and via [links from the LinkedIn page](#) and the Brückner Servtec WeChat channel to the website. **By participating in the Brückner Servtec GmbH raffle, participants accept the following terms and conditions.**

### Eligibility/participation requirements

Employees who are of legal age and have an ongoing employment contract with a company that produces biaxially oriented plastic film for technical and packaging applications are eligible to participate, **provided that consent to participate in the raffle has been obtained from their relevant management.** Brückner Servtec GmbH reserves the right to verify this consent in the period between the start of the raffle and the time at which the prize is actually handed over to the winners.

Employees of the Brückner Group are excluded from participation.  
Participation is only possible once.

### Details of the raffle:

A total of three prizes will be raffled off among all participants who have correctly answered both raffle questions in the entry form:

1. Prize: Audit worth €30,000.00 (Energy, Electrical, Process or Mechanical Audit)
2. Prize: One-off spare parts discount of 15% (max. purchase volume € 750,000)
3. Prize: One 24/7 Expert-on-Demand-Call or alternatively one-time Office Hour support hour increase to 10 hours (the latter is only valid in China)

1<sup>st</sup> prize: The winner can decide which of the four audits offered by Brückner Servtec (energy, electrical, process or mechanical audit) they would like to take advantage of. In this case, any claims for compensation for expenses incurred and claims for damages are excluded. Brückner Servtec GmbH does not assume any liability for any information provided.

### **Data protection notice**

Brückner Servtec GmbH would like to inform you that personal data will be processed in the course of the raffle. The purposes of the processing are shown on the raffle page and the respective processing to which you have consented. The legal basis for the processing of data for the basic implementation of the raffle is Art. 6 para. 1 sentence 1 lit. b GDPR. (fulfillment of a contract). In the case of additional processing, we obtain your consent in accordance with Art. 6 para. 1 sentence 1 letter a GDPR.

The storage period of the data is generally limited to 30 days after the end of the raffle. If you have consented to further processing, the data concerned may be processed by us until you withdraw your consent.

You have the right:

- to request information about your personal data processed by us in accordance with Art. 15 GDPR.
- in accordance with Art. 16 GDPR, to immediately request the correction of incorrect or incomplete personal data stored by us;
- in accordance with Art. 17 GDPR, to demand the deletion of your personal data stored by us, unless the processing is necessary to exercise the right to freedom of expression and information, to fulfill a legal obligation, for reasons of public interest or to assert, exercise or defend legal claims;
- in accordance with Art. 18 GDPR, to demand the restriction of the processing of your personal data if the accuracy of the data is disputed by you, the processing is unlawful but you refuse to delete it and we no longer need the data, but you need it to assert, exercise or defend legal claims or you have lodged an objection to the processing in accordance with Art. 21 GDPR;
- in accordance with Art. 20 GDPR, to receive your personal data that you have provided to us in a structured, commonly used and machine-readable format or to request that it be transmitted to another controller

- in accordance with Art. 7 para. 3 GDPR, to withdraw your consent once given to us at any time. As a result, we may no longer continue the data processing that was based on this consent in the future;
- to lodge a complaint with a supervisory authority pursuant to Art. 77 GDPR. As a rule, you can contact the supervisory authority of your usual place of residence or workplace or our registered office and
- pursuant to Art. 21 GDPR to object to the processing of your personal data, provided that there are reasons for this arising from your particular situation or the objection is directed against direct advertising. In the latter case, you have a general right to object, which will be implemented by us without specifying a particular situation. You have the option of informing us informally of your objection by telephone, email, fax or to the address listed at the beginning of this privacy policy.
